What you need to do it?

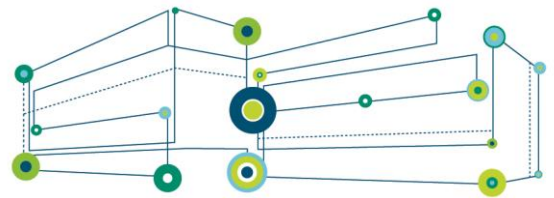
Give us some basic info:

1. Company/Organisation name*
2. Logo*

Supply us with as precise as possible information

3. Product description* (maks. 300 characters)
4. Startup type* choosing from the list
5. Startup FB fanpage / Startup Twitter profile / Startup LinkedIn profile
6. URL to your website or demo
7. Problem / Solution* (maks. 600 characters)
TIP: show us why your product is needed by the market and what challenge you address.
8. Business model / Marketing* (maks. 600 characters)
TIP: show us your selling model and marketing tools/channels you plan to use.
9. Clients* (maks. 600 characters)
TIP: show us your client profile and who exactly your client is.
10. Market* (maks. 600 characters)
TIP: describe the market and show us how big it is and if it is national or international one.
11. Team* (maks. 600 characters)
TIP: show us who is in your team now and what kind of experience and skills you have plus how long you are working together.
12. Money* (maks. 600 characters)
TIP: show us how much money you need to cover the total product costs and how much do you need from potential investors.
13. Why do you want to be a part of infoShare Startup Zone?*(maks. 600 characters)
TIP: show us that you are the one we must have in Startup Zone.
14. Application video URL.

You can also add up to 3 other members of your startup who will be present at infoShare. Remember that they need to register as Attendees before, so we can connect them with your startup form.

Last but not least you need to sign 3 declarations:
