

## infoShare STARTUP CONTEST 2018 REGULATIONS

### 1. Organizers

#### 1.1. Organizers of infoShare Startup Contest [Startup Contest] are:

Fundacja InfoShare having its registered office in Gdańsk (80-309) in the Olivia Connect, ul. Grunwaldzka 472 D, entered into the register of associations and other social and professional organizations, foundations, public health care facilities as well as into the Register of Enterprises in the National Court Register kept by the District Court for Gdańsk–Północ in Gdańsk, 7<sup>th</sup> Commercial Division of the National Court Register, no. 0000374384, NIP [tax identification number] 583-290-74-40

and

infoShare spółka z o.o. with its statutory place of business at Trzy Lipy 3 building C, 80-172 Gdansk, registered in the Gdansk North District Court in Gdansk VII Commercial Division KRS 0000588009, NIP [Tax Identification Number]: 9571082154, with the share capital in the amount of 40.000,- PLN (fully paid)

together named Organizers

#### 1.2. The only partner of Startup Contest is Gdańska Fundacja Przedsiębiorczości having its registered office in Gdańsk, ul. Lęborska 3B, entered in the Register of Enterprises in the National Court Register kept by the District Court for Gdansk-Północ in Gdańsk, 7th Commercial Division of the National Court Register, no. 0000234045, NIP [tax identification number] 583-290-74-40.

### 2. Startup Contest

2.1. Startup Contest is a contest allowing the authors of ideas for innovative business and start-up companies [Startup] to appear before investors invited by Organizers and audience of infoShare conference, which is to take place from 22 to 23 May 2018.

2.2. Startup Contest is a contest dedicated to authors of innovative ideas, with special emphasis on the Central-Eastern region of Europe and the Baltic states, working on a product (seed stage) or having, at least, an MVP (early stage). Startup Contest is not intended for finalists and semi-finalists of the contest's past editions.

2.3. Startup Contest will be held from 1 October 2017 to 23 May 2018.

2.4. Startup Contest is open to companies and individuals not employed with Organizers, who are the sole authors of the Startup idea and enjoy all the rights to the Startup, including property and personal copyrights, providing that the exercise thereof is not in breach of any third-party rights, and who undertake to retain such rights until the day of the Startup Contest finals.

2.5. Entry into Startup Contest means the Startup's acceptance of the infoShare Startup Contest 2018 Regulations in whole. The Startup undertakes to comply with the rules set out in them and confirms that it has met all the conditions for entry into Startup Contest.

2.6. The Startup Contest schedule is available at <http://infoshare.pl/>. Organizers reserve the right to modify the Startup Contest schedule.

### 3. Participation in the Startup Contest

3.1. Startup Contest will be held in three stages.

3.2. Stage 1 – Written application

3.2.1. To apply for entry in the Startup Contest, fill in the entry form available at <http://infoshare.pl/> no later than 28 February 2018. A complete entry form should contain answers to questions prepared by Organizers. The semi-finals will be

- entered by a maximum of 20 start-ups rated the highest by Organizers as well as experts selected by Organizers.
- 3.2.2. Organizers and experts selected by Organizers decides on qualifications for the Startup Contest semi-finals based on its assessment of the pitch deck attached to the application form using 3 criteria rated 0-10 points each: Business potential, Team & Product level of innovation. A maximum of 20 top-rated Startups will enter the Startup Contest semi-finals.
  - 3.2.3. Organizers will publish a list of Start-ups who have qualified for the second stage of the Startup Contest, no later than by 30 March 2018 at <http://infoshare.pl/>
- 3.3. Stage 2 – Semi-finals
    - 3.3.1. Each contestant who qualifies for the 2nd Stage is obliged to present his / her Start-up to investors and experts [Jury] and to infoShare conference audience in the semi-finals, which are to take place at the infoShare conference on 22 May 2018.
    - 3.3.2. The Jury decides on qualifications for the Startup Contest finals based on its assessment of the semi-final presentations using 3 criteria rated 0-10 points each: Business potential, Team & Product level of innovation. A maximum of 5 top-rated Startups will enter the Startup Contest finals.
    - 3.3.3. The members of the semi-finals Jury will be made known at <http://infoshare.pl/> by 30 April 2018.
    - 3.3.4. Organizers will publish a list of the Startups which have qualified for the Startup Contest finals, on 22 May 2018 at <http://infoshare.pl/>.
  - 3.4. Stage 3 - Finals
    - 3.4.1. The Startups which have qualified for the finals will present themselves personally to the Jury and audience at the infoShare conference on 23 May 2018.
    - 3.4.2. The members of the finals Jury will be made known at <http://infoshare.pl/> by 30 April 2018.
    - 3.4.3. The Startup Contest will conclude in a jury session to select the Startup Contest winner. The Jury decides on the winning startup based on its assessment of the final presentations using 3 criteria rated 0-10 points each: Business potential, Team & Product level of innovation.
    - 3.4.4. The winner will be announced on 23 May 2018 at the infoShare conference.
4. Awards.
    - 4.1. The Startup Contest winner will receive the President of the City of Gdansk's award of EUR 20,000 (in words: twenty thousand Euros) gross. If a Polish Startup wins, the pay-out provided by the Community of the City of Gdansk will amount to EUR 20,000 (in words: twenty thousand Euros) at the average exchange rate of the National Bank of Poland, as applicable on the day preceding the day of pay-out.
    - 4.2. The pay-out will be provided by the Community of the City of Gdansk which is also to pay any taxes due on the pay-out.
    - 4.3. The winner is obliged to fill in and deliver a signed declaration which forms Appendix 1 to these Regulations.
    - 4.4. The award will be transferred to a bank account given in the declaration which forms Appendix 1 to these Regulations.
    - 4.5. The winner, who took part in Startup Contest as part of his business activity, is obliged to account for the pay-out as business income, pursuant to Article 12 of the Income Tax for Legal Persons Act [Journal of Laws, 2017, item 2343 as amended] for Polish Startups, or as appropriate for the winner's country of origin.

4.6. For individuals entering Startup Contest, the Community of the City of Gdańsk will reduce the pay-out by the amount of income tax due under Article 30.1.2 of the Income Tax for Natural Persons Act of 26 July 1991 [Journal of Laws 2018, item 200 as amended].

5. Other provisions

- 5.1. Startup Contest will be held in English.
- 5.2. Each Startup is obliged to register at [www.infoshare.pl](http://www.infoshare.pl).
- 5.3. Both application form and pitch decks prepared for any of Startup Contest stages must be prepared in English. Different language will be treated as a formal mistake and will lead to immediate Startup disqualification without a chance to correct.
- 5.4. Any matters not covered by the Start Contest Regulations will be governed by the provisions of the Polish Civil Code and the law of the European Union.
- 5.5. The Organizers reserve the right to modify the Regulations.
