

## infoShare “Startups' Perspective on 2017 & 2018” contest REGULATIONS

### 1. Organizers

The organizers of infoShare “Startups' perspective on 2017 & 2018” contest [**Startups' Perspective**] is Fundacja InfoShare [Organizer] having its registered office in Gdańsk (80-309) in the Olivia Connect, ul. Grunwaldzka 472 D, entered into the register of associations and other social and professional organizations, foundations, public health care facilities as well as into the Register of Enterprises in the National Court Register kept by the District Court for Gdańsk–Północ in Gdańsk, 7<sup>th</sup> Commercial Division of the National Court Register, no. 0000374384, NIP [tax identification number] 583-290-74-40

### 2. Startups' Perspective

- 2.1. Startups' Perspective is a contest allowing the authors of ideas for innovative business and start-up companies [**Startup**] to express their opinions in a Google form: <https://bit.ly/2yhQvBD>.
- 2.2. Startups' Perspective will be held from 13 December 2017 to 07 January 2018.
- 2.3. Entry into Startups' Perspective means the Startup's acceptance of the infoShare “Startups' perspective on 2017 & 2018” Regulations in whole.

### 3. Participation in the Startups' Perspective

- 3.1. Startups' Perspective is held online under the address <https://bit.ly/2yhQvBD>.
- 3.2. Startup fills the form and confirms the answers by clicking the “Send” button.
  - 3.2.1. Experts selected by Organizer [**Jury**] choose 5 most interesting opinions will be granted a free STARTUP PASS for infoShare 2018 conference and if interested, a free stand in the infoShare Startup Expo.
  - 3.2.2. Organizer will inform the winners via email by 15 January 2018.

### 4. Awards.

- 4.1. Every Startups' Perspective winner will receive one STARTUP PASS for infoShare 2018 conference and if interested, one free stand in the infoShare 2018 Startup Expo.
- 4.2. The value of the prizes will vary from 450 PLN (+23% VAT) to 550 PLN (+23% VAT).
- 4.3. The award will be transferred to the winner via the infoShare registration system by 20 January 2018.

### 5. Other provisions

- 5.1. All the answers must be provided in English.
- 5.2. Any matters not covered by the Startups' Perspective Regulations will be governed by the provisions of the Polish Civil Code and the law of the European Union.

- 5.4. Startups' Perspective contest is announced in mass media (Internet).
- 5.5. Startup enters the Startups' Perspective and declares the acceptance of Startups' Perspective Regulations by clicking the “Send” button in the form.

By entering the contest Startups authorize the Organizer to process their personal data for the needs of the Startups' Perspective contest in accordance with the Personal Data Protection Act dated 29.08.1997 (uniform text: Journal of Laws of the Republic of Poland 2002 No 101, item 926 with further amendments). The Organizer is the administrator of the data.
